To avoid any doubt, claims cannot be made for occupier accounts or premises that are vacant on these dates.

** 'Claimants in Embedded Networks' are residential claimants of the retailer's exempt seller customers claimed for via Form 531.

*** 'Vulnerable Households' are those who are recipients of the existing Queensland Electricity Rebate (\$372.20 per annum) on the date the Cost of Living Rebate is applied to eligible accounts, i.e. 01 July 2023 for embedded network customers and retailers (or alternate Quarter 1 date), 01 October 2023, 01 January 2024 or 01 April 2024.

Note: Forms for residential claimants must be **submitted by 31 December 2024** as the final cut-off date for the 2023-24 Queensland Government Cost of Living Rebate. Applications for embedded network claimants submitted after 31 December 2024 will be considered on a case by case basis.

I hereby certify that:

- The Queensland Government Cost of Living Rebate 2023-24 payment detailed on this claim is only for those consumers who meet the definitions of 'Residential Claimants', 'Claimants in Embedded Networks' and 'Vulnerable Households' detailed on this form;
- The number provided at "Claimants in Embedded Networks" is the total of the figures provided by Embedded Network Operators that are customers of the Retailer;
